BY MAIL: enter your appearance by completing the plea form above and mailing it to the court by court appearance dated listed on citation

ALL PERSONS UNDER 17 must appear in person before the judge with parent or legal guardian or proof of marriage. NO PLEAS BY MAIL.

PERSONS UNDER 21 CHARGED WITH ALCOHOL-RELATED OFFENSE must appear in person before the judge with parent or guardian. NO PLEAS BY MAIL.

PERSONS UNDER 18 CHARGED WITH TOBACCO OFFENSES must appear in person before the judge.
